

TECHNICAL REQUIREMENTS FOR FORMATION OF REPORTS

General requirements:

- Page format: A4, margins - 2 cm on all sides
- Font: Times New Roman
- Paragraph: Justified, First line - 1.25 cm, Row spacing - Single

Title: Times New Roman, 14 pt, Bold, Centered, Uppercase. An empty line follows.

Author (s): Write the name and surname of the author (authors); Times New Roman, 12 pt, Bold, centered. An empty line follows.

Institution: write the full name of the university; Times New Roman, 12 pt, Bold, Centered. An empty line follows.

Summary in Bulgarian: 250 - 300 words; Times New Roman, 12 pt, Justified, First line - 1.25 cm. An empty line follows.

Summary in English: 250 - 300 words; Times New Roman, 12 pt, Justified, First line - 1.25 cm. An empty line follows.

Keywords in Bulgarian language: 3 - 5 words; Times New Roman, 12 pt, Justified, First line - 1.25 cm. An empty line follows.

Keywords in English: 3 - 5 words; Times New Roman, 12 pt, Justified, First line - 1.25 cm.. An empty line follows.

Text of the report: Times New Roman, 12 pt, Justified, First line - 1.25 cm.

Citation: The sources are indicated under footnotes, automatically entered with a sequence number in the text; Times New Roman, 10 pt, Justified. The same goes for footnotes.

Bibliography: An empty line after the main text; Times New Roman, 12 pt, Bold, Justified, First line - 1.25 cm.

An empty line follows. The next one starts the alphabetical order of the authors sequence of surnames. The authors, written in Cyrillic, are listed first, followed by this - again in alphabetical order - those in Latin, finally the electronic sources are indicated.
